

Assumption of the Risk, Waiver and Release of Liability Relating to COVID-19

Dynamo FC (the “Club”) has put in place preventative measures to reduce the spread of COVID-19 (the **“Return to Play Protocols”**); however, the Club cannot guarantee that you, your spouse, your child(ren) (the **“Player(s)”**), other family members, or guests (collectively the **“Participants”**) will avoid infection. Further, attending or participating in practices, training, tryouts, scrimmages, games, and tournaments (collectively the **“Club Activities”**) may increase the Participants’ risk of contracting COVID-19.

In consideration of the Player(s) named below being allowed to attend and participate in Club Activities, I, for and on behalf of the Participants, sign this Assumption of the Risk, Waiver and Release of Liability Relating to COVID-19 (the **“Agreement”**). By signing this Agreement, I, for and on behalf of the Participants:

1. Acknowledge the contagious nature of COVID-19 and understand that the risk of becoming exposed to or infected by COVID-19 while attending or participating in Club Activities may result from the actions, omissions, or negligence of the Participants and others, including, but not limited to, the Club, its directors, contractors, employees, and volunteers, other Club participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used to conduct Club Activities including the Metropolitan School District of Washington Township, First Baptist Church of Indianapolis, and Tabernacle Presbyterian Church (collectively the **“Releasees”**).
2. Freely and voluntarily assume the risk that the Participants may be exposed to or infected by COVID-19 by attending or participating in Club Activities and that such exposure or infection may result in injury to the Participants including, but not limited to, personal injury, illness, permanent disability, and death (collectively the **“Risks”**), and assume full responsibility for the Participants’ attendance at and participation in Club Activities.
3. Hereby release, discharge and hold harmless and waive my right to sue the Releasees of and from any and all Risks, claims, liabilities, actions, damages, costs or expenses of any kind (collectively the **“Claims”**), whether known or unknown, arising out of or relating to the Participants’ attendance at or participation in the Club Activities. I understand and agree that this release includes any Claims based on the action, omissions, or negligence of the Releasees.
4. Agree to comply with the Return to Play Protocols implemented by the Club and other preventative measures recommended by federal, state, and local governments and federal and state health agencies to reduce the spread of COVID-19 or, at the Club’s sole discretion, forfeit the opportunity to attend or participate in Club Activities as a result of noncompliance.
5. Agree that if any Player(s) named below has:
 - A temperature of 100.4 F or above,
 - Any COVID related symptoms (cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell, all of which have been identified by the CDC as possible symptoms of COVID-19),
 - Had a positive COVID-19 test in the past fourteen (14) days, or
 - Had close contact (i.e., in the Player’s household or within 6 feet) in the last fourteen days with an individual who has tested positive for COVID-19 or who showed symptoms of COVID-19,

the Player will not attend or participate in Club Activities and will immediately contact the Executive Director of the Club, Ric Huffman, at rhuffman@dynamofc.org.
